

Are you a Colorado resident moving to or out of Park County?

If you are a Colorado resident and are moving to Park County with a concealed handgun permit, you need to contact the agency that originally issued your permit, within 30 days after your move. When your permit is due for renewal, you must contact the Sheriff of the County in which you reside, or the Sheriff of the County in which you maintain a secondary residence, or the Sheriff of the County in which you own or lease real property used for a business.

If you are moving away from Park County, to another county in Colorado, and are a Park County CHP holder, you need to contact the Park County Sheriff's Office to inform us of your move. When your permit is due for renewal, you must contact the Sheriff of the County in which you reside, or the Sheriff of the County in which you maintain a secondary residence, or the Sheriff of the County in which you own or lease real property used for a business.

## Concealed Handgun Permit Application Procedures

**Appointments are required for all CHP procedures.**

**Please call the Sheriff's Office in Fairplay at 719-836-2494.**

## New Applicants:

The following is what you can expect at your appointment with the Sheriff's Office:

- Witnessing of your signature and submittal of completed application
- A copy made of your valid Colorado Driver's License
- A copy made of your certificate from a certified instructor showing competency with a handgun
- Required separate payments of \$100 for permit fee and \$52.50 for background check. We accept only cash, check or money order.
- Photo taken
- Fingerprints scanned

## Renewing Applicants:

The following is what you can expect at your appointment with the Sheriff's Office:

- Witnessing of your signature and submittal of completed application
- A copy made of your valid Colorado Driver's License
- Required separate payments of \$50 for permit fee and \$13.00 for background check. We accept only cash, check or money order
- Photo taken

\*\*\*Persons renewing from out-of-county will also need to bring their CHP from the previous county of issue.\*\*\*

## Expired Permits:

Concealed Handgun Permits are valid for a period of 5 years. You have up to 120 days prior to the expiration date to begin the renewing process with the Sheriff's Office. You may still renew within 6 months *after* the permit has expired, however there is an additional fee of \$15.00 for the late renewal. No permit shall be renewed 6 months or more after its expiration date. That permit shall be deemed null and void.

**Your Concealed Handgun Permit will be mailed to you in approximately 4 - 6 weeks after your appointment.**

## Lost, Stolen, or Destroyed Permits:

If a permit is lost, stolen, or destroyed, the permit is automatically invalid. The person to whom the permit was issued may obtain a duplicate or substitute for a \$15.00 charge upon submission of a notarized Lost/Destroyed Permit form. Lost, stolen or destroyed permits must be reported to the Sheriff's Office within 3 days.

## Address Changes:

Within 30 days after a permit holder changes the address specified on his or her permit, the permit holder shall notify the issuing Sheriff in writing of the change of address.

## Out of State/Reciprocity:

A permit to carry a concealed handgun or a concealed weapon that is issued by a state that reciprocates with Colorado shall be valid in all respects as long as the person is at least 21 years of age, is a resident of the state that issued the permit, or is a resident of Colorado for not more than 90 days. After 90 days of residency, you may continue to hold your out of state permit, but shall apply for a Concealed Handgun Permit for the state of Colorado.
