

PURPOSE

The purpose of this document is to summarize all post-it note comments collected from the Park County Strategic Master Plan Update Workshop Series. During the week of September 21-25, workshops were held in Hartsel, Fairplay, Bailey, Lake George, Guffey and Alma. The comments collected from these workshops are organized by vision question (below) and grouped into themes. Each theme begins with general comments (countywide, or mentioned by all) followed by comments associated with a specific location, (Fairplay, Hartsel...). The numbers in the parentheses (3) indicate the number of individual comments collected at the workshops that were the same or similar to that particular comment or topic.

BACKGROUND

A total of 109 community members attended the Community Workshops throughout Park County to help planners create the master plan vision statements, the first step in developing and up-to-date Strategic Master Plan for Park County. One exercise during the Community Workshops was an interactive, energetic event with small and large group discussions structured on these questions:

- What do we treasure and want to preserve about Park County?
- What concerns do we have about Park County and what changes are needed for the future?
