

SECOND ADDENDUM TO INTERGOVERNMENTAL AGREEMENT

This is the Second Addendum to the Intergovernmental Agreement between La Plata County and Park County Regarding Social Services, entered into on January 28, 2020, by and between the Board of County Commissioners of La Plata County, Colorado ("La Plata County" or "La Plata County Board") and the Board of County Commissioners of Park County, Colorado ("Park County" or "Park County Board"), in their respective capacities and sitting as the County Boards of Social Services as defined in C.R.S. § 26-1-103(1) and § 26-1-116(l)(a).

This Second Addendum is hereby expressly incorporated into the January 28, 2020 Agreement between La Plata County and Park County. To the extent that the terms of the Agreement and this Addendum conflict, the terms of this Second Addendum shall control.

The following provisions are hereby added and incorporated into the above-referenced Agreement:

The parties wish to extend the Intergovernmental Agreement from January 1, 2021 through to December 31, 2021.

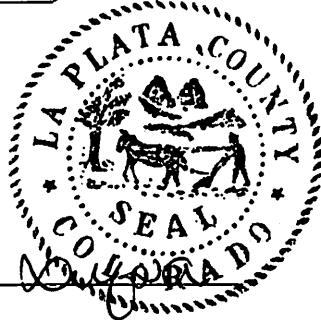
The parties wish to agree that new wages apply pursuant to **Exhibit B**, for a period from September 1, 2020 to the end of the extended Agreement, December 31, 2021. These wages represent a pay increase for Park County employees that was effective September 1, 2020.

The parties wish the maximum cost of services as contained in **Exhibit B** to be an amount not to exceed \$50,000 for the time period of January 1, 2020 through to December 31, 2020, and an amount not to exceed \$50,000 for the time period of January 1, 2021 through to December 31, 2021. The **Exhibit B** attached to this Second Addendum will replace the Exhibit B contained in the January 28, 2020 Agreement as modified in the First Addendum, which was executed on March 18, 2020.

Except as modified herein, all terms and conditions of the existing Agreement between the parties remain in full force and effect.

EXHIBIT "B"
Compensation Rate

Park County shall be compensated by La Plata County for the provision of the Services in Exhibit A as follows: La Plata County shall pay the Park County employee's overtime rate when this work is completed outside of each employee's regular 40-hour work week, which will be at the overtime rates of \$44.70 per hour, \$37.88 per hour, \$31.99 per hour, \$26.68 per hour, \$25.47 per hour, \$29.94 per hour, \$37.27 per hour, or \$28.05 per hour, depending on the individual staff member's regular compensation, for Services rendered by Park County Eligibility Technicians and supervisors. If Park County staff members are able to complete La Plata County work within the standard 40-hour work week, they shall be paid their usual base pay plus benefits. Hours and compensation provided for Services shall be mutually agreed upon prior to the provision of services by La Plata County and Park County. The cost of services shall not exceed \$50,000.00, for the period between January 1, 2020 and December 31, 2020, unless mutually agreed upon by both parties. The cost of services shall not exceed \$50,000.00 for the period between January 1, 2021 and December 31, 2021, unless mutually agreed upon by both parties.

Each Park County Eligibility Technician and supervisor subject to the terms of this Agreement shall complete monthly time reporting sheets to document the services and the time spent providing Services to La Plata County. All billing will occur based on actual cost of salaries and benefits of the eligibility technicians and supervisors who are completing the case specific tasks.
